MIDDLETOWN TOWN COUNCIL MEETING MINUTES NOVEMBER 10, 2014

The Middletown Town Council Meeting was held in the Council Chamber, 7875 Church Street, Middletown, VA on Monday November 10, 2014 at 7:00 p.m.

1. Call to Order

Mayor Harbaugh called the meeting to order at 7:00 p.m.

2. Moment of Silence

Mayor Harbaugh asked for a moment of silence.

3. Pledge of Allegiance

Mayor Harbaugh led those present in the Pledge of Allegiance.

5. Set Agenda

Mayor Harbaugh made a motion to set the agenda. Councilor Simon amended the agenda under Public Works Committee asking for a vote to request a proposal for a water and sewer rate study. Councilor Aliff seconded the motion. All Councilors were in favor with the exception of Councilor Copeland.

6. Citizen Comments

Sherry Bohnenkemp at 90 Reliance Road states the parking ordinance is not business friendly and it is a government putting regulations telling me who can and cannot park in my lot and targeting a certain group of people, truck drivers for no reason. Liberty has been here longer than the people living behind the store. They knew that they were living behind a 24 hour convenience store with truck parking. If the ordinance is passed this encroaches on my rights as a business owner. Truck drivers spend money at the store in the upwards of \$40,000 and brings revenue to the Town. Some of the drivers are residents of the Town. It is law that drivers take a break. Liberty allows a safe place for drivers to rest and eat a good meal. A parking ordinance is not going to stop littering, peeing in a parking lot or prostitution if it is going on. This ordinance is nowhere on the agenda in August, September or October. She ask that the Council vote on the best interest of the Town and vote against this ordinance.

David Harrison at 305 Reliance Road Middletown states he is a truck driver that parks over there (Liberty) and has been for 25 years. Liberty is a good place to stop. He states he has been over there when Yancey has been over there confronting people and he has confronted him before and gotten in fights with truck drivers. Yancey has had his dog over there urinating on peoples wheels. You can get on Google map and look their property up (Yancey). His understanding is they (Yancey) lived up in Stephens City behind Athey trucking and they also complained about trucks up there but yet they move down here and by a place right by a place that has truck drivers. They live right on top of the interstate and you can hear the interstate 24 hours a day. It seems to me that the issue is the trucks not the noise. If you guys pass this ordinance you are going to have guys out on the interstate sleepy wrecking and killing people. He states he is not in favor of this ordinance.

Chuck Gurtler at 104 Anderson Avenue Winchester states he is here to represent Sherry and her business. He states there is a noise issue but Liberty has been there before them houses. He lives in a noisy area and you just have to get use to it if you choose to live near a 24 hour convenience store with truck parking. If this is passed (inaudible) He states as far as he is concerned this business should be grandfathered in and the ordinance should not be passed. He states he is not a truck driver but goes there to eat because the food is good.

Cecelia Orebaugh at 105 Clark Road Stephens City states she is her to speak for the truckers. The truckers are hard working men and women that haul items we need and use every day. Where would we be if we did not have them transporting our goods? She states she worked at Liberty and the guys would come in and ask "can we stay" I know the signs say 1 hour but our trucks are down and I am tired, hungry and will fall asleep out there. If those complaining don't like the trucks why don't they move instead of walking around the parking lot harassing the truckers? If you don't like it then why move into a place where they have truck parking? Are you going to install parking meters and put 9 people in a kiosk to say how long someone has been here? There is nothing wrong with the store parking lot and it is business for the Town. The Town needs to drum up business not run businesses out of town. Is the Town going to allow one or two people who do not like the noise speak for the whole Town and pass this ordinance? The ones complaining use to come in to the store and laugh with the truckers so why the change? Is it personal?

Yancey Sine at 2130 Mark Drive states he wants to respond. He states he has nothing personal against her or the store. The problem started when the barriers were removed. This stuff about beating on doors and yelling at people is a lie. I had one driver cuss me and I was in my yard. I had one driver out there at 3 in the morning yelling helping someone back up. I went in that store for 6 years and yes I stood in there and talked to them people and I do not have anything against that store or the truckers and my dog never peed on anybody's tires. I have more respect than to get up here and lie and I clean after my dog.
