3. Citizen Comments (3 minutes per person per meeting – max 30 minutes)

Stephanie Mitchell 8049 Main Street – stated she is against the new development because she believes "it will adversely impact the historic nature and character of the town". "Once a small town is lost, it is lost forever". Mitchell also shared her concerns about the traffic and noise which will come with the new development.

Tom Lash 8046 Main Street – recapped previous objections against the new development from the Planning Commission Public Hearing. Mr. Lash is highly opposed to the growth that the town will endure with the new development.

Sue Teal 7846 Main Street – stated we "southern Frederick County" does not need and cannot afford the amount of mass produced, high density residential development. She advised the revised proffer plan is an improvement from the previous plan in 2008. She also pointed out if the amended proffers are not approved, the previous proffers will be implemented by-right. She also expressed her sincere sympathy to council citing "they have indeed inherited a mess from former administration".

Nathan Hast 7984 Main Street – stated we cannot stand to take on any more traffic as we will lose the small-town feel. He expressed he is opposed to the new development.

Karen Beck Herzog (National Park Service) & Kristen Laise (Belle Grove Planation Executive Director) both expressed concerns stating "the viewshed, the historic nature of this town is rapidly changing with the development that is already underway. Laise advised to develop this property would mean every thoroughfare into the Town of Middletown would be like driving through a mass, dense development property. She urged council to be careful about their decisions regarding additional development.

Leary Boyd 8007 Church Street – spoke against the new development citing traffic on Church Street is already significant and with more development it will only increase.
