His comments were focused on **Enfield Knolls**, land disturbance permit has been issused by Frederick County and will be breaking ground soon. **Village of Middletown**, Phase II, Three (3) buildings permits have been applied for to date and construction will start soon, **Zoning Ordinances**, amended to add new section to Article III Supplementary Regulations 17-22 Landfill, Junkyards, Trash Disposal and

Inoperable Vehicles will be added to 17.1, as well as Automobile Graveyards, along with this amendment. Article Supplementary Regulation 17-23, Outside Storage Prohibited, has been rewritten to bring to state standards with a few wording changes. Article IV 17-24 Nonconforming Uses, has been rewritten to bring to state standards and clean up the old sections, replacing 17-22, 17-23, 17-24, 17-25, 17-26, 17-27, 17-28, 17-29, 17-30 and 17-31.
