### 1. Set Agenda

Chairwoman Morelock called for a motion to adopt the agenda. Commissioner Boring motioned to approve the agenda as presented, seconded by Commissioner Berger. The motion carried unanimously.

These included offering raffle tickets to attendees who completed the survey on-site, distributing promotional bookmarks, printing sign boards featuring a QR code link to the survey, and launching an additional social media push.

Ms. Kerns noted she would coordinate with the consultants to obtain appropriate graphics for sign printing and updated images for social media promotion. Commissioners also requested paper copies of the survey to have available at the event for attendees who preferred to complete a hard copy.
